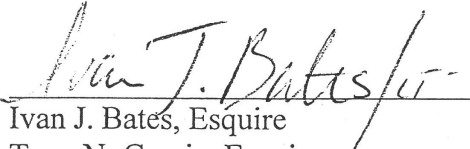
**DEFENDANTS' JOINT MOTION FOR RECORDATION OF

Defendants, by their respective undersigned counsel, hereby request recordation of the September 24, 2015 scheduling conference. In support thereof, Defendants state as follows:

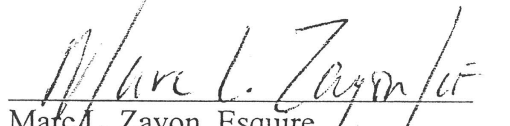
1. Defendants have been informed that this Honorable Court wishes to meet with the parties in this matter for a Scheduling Conference on September 24, 2015.
